## INDEPENDENT AGENT'S AGREEMENT

### *Thompson Chain-Reference® Bible Products*

B. B. Kirkbride Bible Company, Inc., of Indianapolis, Indiana offers the following Independent Agent's Agreement for selling the *Thompson Chain Reference® Bible* and related products.

**DISCOUNTS:** Your discount on all products is 25% or 35% (depending on the agent level attained and maintained), unless otherwise advised by Kirkbride Bible Company. All discounts are based on current retail prices. This signed Application/Agreement must be sent in with your first order for two (2) or more Bibles for you to receive the agent discount. NO EXCEPTIONS! After your initial order, you may order as needed with no minimum on quantity requirement. However, to attain the 35% level, you must order a total of six (6) Bibles within the first 60 days. Your Independent Agent discount will remain in effect until your renewal date unless cancelled in writing by yourself or Kirkbride Bible Company.

**SPECIAL OFFERS:** Several times a year you will receive "The chain Link" newsletter advising of special offers and close-outs with a greater than normal discount.

**PAYMENTS:** Payment in full must accompany the Independent Agent's first order. Remittances should be in the form of a Money Order or Personal check. Kirkbride also accepts payment by Visa, MasterCard, American Express, or Discover (please include charge card account number and expiration date). Visa, MasterCard, American Express or Discover accounts must be in the Independent Agent's own name. We will not charge cards in your customer's name. We do not accept third party checks – any customer checks sent with your orders must be made out directly to Kirkbride. All transactions are made in American funds only.

**CREDIT OPTIONS:** After the first order and upon acceptance and approval of credit information, the Independent Agent may order on an open account basis. Invoices are sent at the time of shipment and are due within 30 days. Your Kirkbride account is a privilege and may be revoked if abused.

**DELINQUENT ACCOUNTS:** Accounts which are past due will be assessed a service charge of 1 ½% per month on the overdue balance. Independent Agents are liable for all charges placed on their account, including returned check fees, collection agency and/or attorney fees, etc.

**SHIPPING:** Orders are sent Parcel Post Book rate to post office box addresses or U.P.S. to street addresses, unless otherwise requested. We prefer to ship via U.P.S. to a street address so that shipments are readily traceable. All shipping charges are the responsibility of the Independent Agent. All charges for special shipping request are billed to the Independent Agent. A shipping release form is required for all overseas shipments.

**NAME IMPRINTS:** All requests for engraving of names on Bibles should be printed legibly and sent through the mail. Engraved Bibles may not be returned. Note: There is no Independent Agent discount on engraving charges.

**RETURNS:** A customer may examine a Bible for ten (10) days and return for full refund (unless engraved) provided the Bible can be put back into new stock for resale. It is usually best for the Independent Agent to handle the return, and a return authorization must be obtained from Kirkbride prior to returning the product.

**Bibles which wear out are not subject to return!**

**Miscellaneous:** Bible cases cannot be engraved.
